Policy:

This Whistleblower Policy is intended to encourage and enable employees and others to raise serious concerns internally so that the foundation can address and correct inappropriate conduct and actions. It is the responsibility of all board members, officers, employees, and volunteers to report concerns about violations of the foundation's code of ethics or suspected violations of law or regulations that govern the foundation's operations.

Reporting Responsibility:

Any employee, volunteer, or associate of the Songs of Love Foundation who suspects that unethical, illegal, or fraudulent activities are taking place is encouraged to report their concerns. Reports can be made anonymously if the individual prefers.

Procedure:

1. Reporting Violations:

- Reports of suspected violations should be submitted in writing to the Executive Director or, if the reporter is uncomfortable speaking with the Executive Director, to the Chair of the Board of Directors.

- The report should contain specific information including what, when, where, and how the suspected violation occurred, and any evidence or witnesses that support the allegation.

2. Investigation:

- The Executive Director or the Chair of the Board of Directors will promptly investigate all reports.

- Investigations will be conducted with discretion and confidentiality to the extent possible, consistent with the need to conduct an adequate investigation.

3. Protection from Retaliation:

- The Songs of Love Foundation will not retaliate against anyone who, in good faith, reports a concern, participates in an investigation, or refuses to participate in activities that violate the law or this policy.

- Any form of retaliation against whistleblowers is strictly prohibited and will result in disciplinary action, including potential termination of employment or volunteer status.

4. Confidentiality:

- The foundation will make every effort to maintain the confidentiality of the whistleblower, consistent with the need to conduct a thorough investigation and take necessary corrective action.

Acting in Good Faith:

Anyone filing a complaint concerning a violation or suspected violation must act in good faith and have reasonable grounds for believing the information disclosed indicates a violation. Any allegations that prove to be unfounded and that prove to have been made maliciously or knowingly to be false will be viewed as a serious disciplinary offense.

Acknowledgement and Compliance:

All employees, volunteers, and associates of the Songs of Love Foundation are required to acknowledge that they have read and understand this policy
